DIRECTIONS TO TRIAL SITE — SOLANO COUNTY FAIRGROUNDS, Vallejo, CA.

- Take Interstate 80 either west or east to Vallejo.
- Take the Highway 37 exit, then take the first exit (Fairgrounds and Marine World).
- Proceed south for two blocks and turn left into the main entrance parking lot of the fairgrounds.

PARKING -- All vehicles must enter through the main parking entrance. There will be a parking fee of \$5.00. The Shiba Inu ring is located inside the Exposition Building. **NO DRIVING** will be allowed on the show site. Be prepared to haul your equipment from the parking lot to ringside.

Go to first signal and turn left onto Central Place. The vet clinic is one block up on right. Travel time is approximately 15 minutes from fairgrounds.
